RELEASE AND INDEMNIFICATION AGREEMENT

IN CONSIDERATION of my being given permission to observe and/or participate in the shooting, sporting and outdoor activities at the Kern River Valley Gun Association, I agree to sign and enter into this release and indemnification agreement.

I am entering into this agreement freely, voluntarily, and specifically state that:

1. I am not dazed, suffering from shock or under the influence of drugs or alcohol;
2. I understand that this is a full and complete release and indemnification agreement; and
3. There has been no fraud or other conduct used in obtaining my signature and agreement to this document.

I will comply with all rules and regulations. If I have questions, or observe any unusual or unnecessary hazard during my participation, I will immediately bring such to the attention of the nearest official, and I have read all range rules and will comply with completely.

I understand that the observation and/or participation in the shooting, sporting and outdoor activities will expose me to certain risks inherent to the use of firearms and related activities. These include, but are not limited to, personal or bodily injury, death and/or property damage.

I agree to assume and accept the dangers inherent in the observation and/or participation of the shooting, sporting and outdoor activities.

I represent that I have no drug, health or mental problem that could or will interfere with my observation and/or participation of the shooting, sporting and outdoor activities.

I agree that I am responsible for my own safety and the safety of any guest or child that I may bring to the premises of the Kern River Valley Gun Association.

I agree that the Kern River Valley Gun Association, its members, officers, directors, employees, agents, representatives, affiliates, subsidiaries, successors or assignees and all participating groups and persons officially connected with the activities, including but not limited to the Kern River Valley Gun Association, will not be liable if I, my guest or child suffer any personal or bodily injury, death or property damage as a result of ordinary negligence.

I further agree that in the event that the Kern River Valley Gun Association, its members, officers, directors, employees, agents, representatives, affiliates, subsidiaries, successors or assignees and all participating groups and persons officially connected with the activities, including but not limited to the Kern River Valley Gun Association, and become liable by way of contribution, indemnification, judgment, verdict, award or otherwise, to any other party as a result of my actions, negligence or injury, I agree to indemnify and hold harmless the Kern River Valley Gun Association, its members, officers, directors, employees, agents, representatives, affiliates, subsidiaries, successors or assignees and all participating groups and persons officially connected with the activities, including but not limited to the Kern River Valley Gun Association, from any and all claims, demands, actual legal costs or other costs or expenses arising out of said actions, negligence, or injury, no matter who might bring said claim, if any be brought.
